

Alternative Fuel Vehicle Rebates for Consumers

Great news! We've retooled our rebates program to help more working-class Pennsylvanians enjoy the benefits of zero-emission electric vehicles or low-emission vehicles.

Rebates are currently available. The program is expected to run until June 30, 2023.

What's Changed

Here are the main changes:

1. The maximum household income levels eligible for a rebate are lower.

Household income is what's reported in line 9 of the federal 1040 tax form.

as defined by the U.S. Department of Health and Human Serv ices (https://aspe.hhs.gov/poverty-guidelines)

**Levels are no more than 200 percent above the federal income poverty level.

2. The rebate for battery electric cars and trucks is higher.

• Battery electric cars and trucks qualify for a \$2,000 rebate (up from \$750). *Example:* A family of two with a household income of \$69,000 is eligible for a \$2,000 rebate for a battery electric vehicle. A family of two with a household income of \$35,000 is eligible for a \$3,000 rebate for a battery electric vehicle.

^{*}Levels are no more than 400 percent above the federal income poverty level,

- Plug-in hybrid cars and trucks qualify for a \$1,500 rebate.
- All other alternative fuel vehicles, and electric motorcycles, qualify for a \$500 rebate.
 - 3. The rebate amount is now the same for new and preowned vehicles.

How to Apply

 The program will offer at least 1,000 rebates through the program starting September 1, 2022 until June 30, 2023
 Rebates are offered to Pennsylvania residents only. (Companies, nonprofit organizations, and government agencies are invited to apply for

Rebates are offered on a first-come, first-served basis as long as funding is available. Rebates are subject to the

Eligible Vehicles

New, Pre-Owned, and Demonstration vehicles with final purchase price of \$50,000 or less (purchase or lease):

\$2,000 rebate on:

- Battery electric vehicle
 \$1,500 rebate on:
- Plug-in hybrid electric vehicle \$500 rebate on:

- Compressed natural gas vehicle
- Propane fueled vehicle
- Electric motorcycle (Does not include electric scooters)

One-time pre-owned vehicles:

- Odometer reading of 75,000 miles or less
- Final purchase price of \$50,000 or less
- Purchased from a registered dealer

Demonstration vehicles:

- From a registered dealer
- Final purchase price of \$50,000 or less
- Odometer reading: Over 500 and less than 10,000 miles

Additional low-income rebates:

An additional \$1,000 is available to applicants who meet low-income requirements. For details, see
